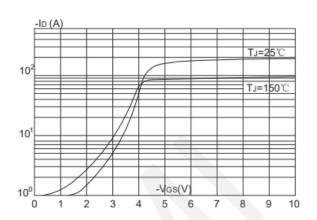

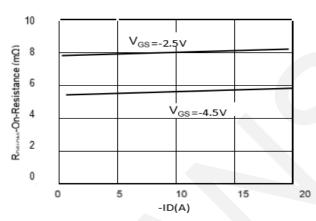

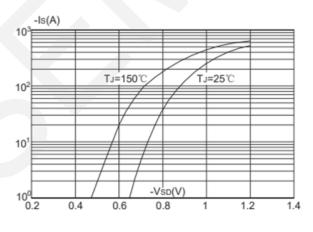
Output Characteristics



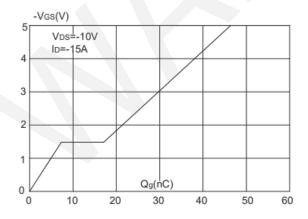
Typical Transfer Characteristics



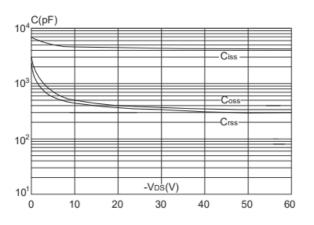
On-Resistance vs. Drain Current and Gate



Body Diode Characteristics

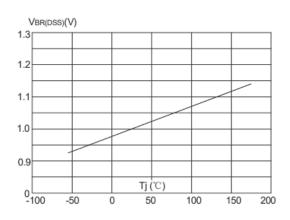


Gate Charge Characteristics

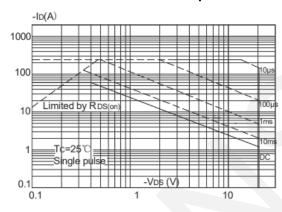


Capacitance Characteristics

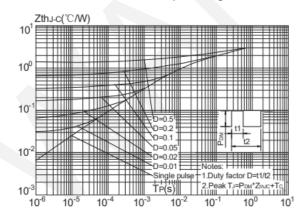




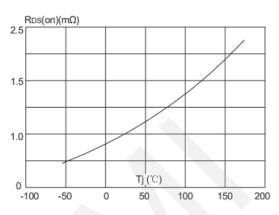
Normalized Breakdown Voltage vs. Junction Temperature



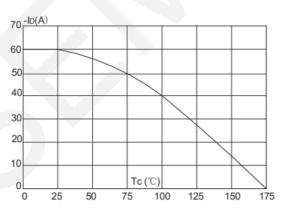
Maximum Safe Operating Area



Maximum Effective Transient Thermal Impedance, Junction-to Case



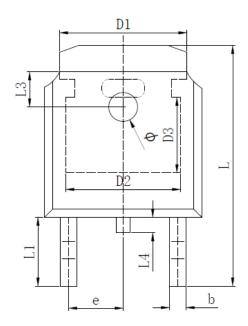
Normalized on Resistance vs. Junction Temperature

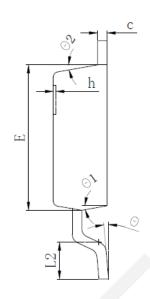


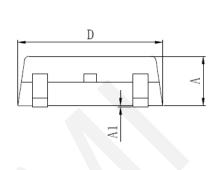
Maximum Continuous Drain Current vs. Case Temperature
